- 2 - Includes Drug Medi-Cal (DMC) approved and submitted-pending payment claims only for those whose aid codes indicate eligibility for DMC program funding. Denied claims are not included.
- 3 - Based upon the most recent data processing of DMC approved and submitted-pending payment claims and MEDS Monthly Extract File(MMEF) by DHCS for the reported Fiscal Year.
- 4 - County total number of yearly unduplicated Drug Medi-Cal eligibles is .
