County Updates</p> <ul style="list-style-type: none"> Health Management Associates HMA Community planning process- Will be hearing from them, focus groups, KII, community input as they develop plan that will be submitted to state August- changes to screening process to align with Medi-Cal screening tool and resulted in uptick of referrals to HN over 40 for the month of August. <p>Data Exchange</p> <ul style="list-style-type: none"> Data Exchange: Ryan to send Dustin staff for SFTP CalMHSA Data exchange- trying to have closed loop referral system. The pilot is looking to get implemented in 2026. Does HN have a CLR tool? Working on this internally HIE integration with CalMHSA- Meeting with HN and ICDBH (Dustin, Ryan and Bryan) 	<p>Imperial County Team</p>
<p>VI. Care Coordination</p> <ul style="list-style-type: none"> Every member that is referred also receives a CM referral. This can help bridge the gap. During the linking process after TOC tool- their current provider continues to see them so they don't run out of medication. <ul style="list-style-type: none"> ICDBH doesn't want to discharge patients until they know the patient has connected with the new Provider. 	<p>All</p>

Referrals</p> <p>Disposition</p> <ul style="list-style-type: none"> Amount of time to reach member and get back can take some time <ul style="list-style-type: none"> Any cases with questions reach out to Myriah + team Screening tool/referrals: Members getting screened with NSMHS but don't have a reliable form of communication. Is there best practices for these types of member? <ul style="list-style-type: none"> Not uncommon challenge- Make sure that they have Health Net phone number so they can reach out when it's convenient for them to connect with a clinician. At the time of screening, they can call with them in the office. 	<p>All</p>

(ICDBH will think about this) • Is there a way to link coordination with the referring provider so they can link together? <ul style="list-style-type: none"> ○ At the Health Plan, providers maintain their own records so the MCP doesn't have the records, the specific Providers have that. • Transition of care tool- is the MCP sharing this information to the Providers? <ul style="list-style-type: none"> ○ No they MCP doesn't do this. Myriah will look into this to see if the MCP can share this to a referring Provider. • Is there a way that the MCP can share who the referring Provider is with ICDBH? This will help apprehensive clients moving to another system. Warm handoff is to the MCP and not to the Provider. Need to connect with the Provider and not just the MCP. <p>Scenario question with screening tool</p> <ul style="list-style-type: none"> • Screening tool completed, but the member comes in person to ICDBH the next day. What happens to the completed the referral to the MCP? How to notify the MCP? <ul style="list-style-type: none"> ○ Wait to retract the referral, wait to see the outcome of the referral and then reach out to the MCP
